## Key Details

# 1. Definitions

In these terms and conditions, the following definitions apply:

"JEPCO" means JEPCO (Marketing) Limited, whose registered office is Norfolk House Farm, Gedney Marsh, Spalding, Lincs. PE12 9PB.
